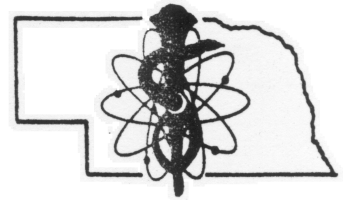

## TECHNOLOGIST OF THE YEAR AWARD

**RATIONALE:** The award is presented, by the NSRT, to express appreciation and recognition.

**BACKGROUND:** The award, initiated in 1996, is to recognize an outstanding technologist of the NSRT. The purpose of the award is recognition, appreciation and visibility. A plaque and registration to NSRT Annual Conference will be presented to the recipient of the award. This award is to be sponsored by Bracco Diagnostics via their representative.

**NOMINATIONS:** Fellow technologists will submit, to the NSRT, names of technologists, prior to the Fall Seminar. All nominations will be received by a deadline date of October 1st, with the nomination form to be obtained from the NSRT Executive Secretary.

### CRITERIA:

1. Be a current member of the NSRT.
2. Must be registered by the ARRT and certified by the State of Nebraska.
3. Must have practiced the Radiologic Sciences for at least 5 years.
4. Must have a good attitude, compatibility, pride in work, willingness to do more than is required and dedication to the profession.
5. Technologists, who are nominated, should be recognized for accomplishments over and above normal requirements of performance.

**SELECTION:** The nominees will be selected by a committee of five. These will include the following:

1. NSRT President
2. NSRT Advisory Board Member
3. An individual familiar with the Radiologic Technology profession
4. NSRT Medical Advisor or Radiologist on the Advisory Board
5. Bracco Representative

**IMPLEMENTATION:** The nomination committee will review the nomination forms and announce the winner no later than February 1st.
